Dear Prime-Minister,

More than 100 days have passed since your appointment as a Prime Minister of the Republic of Armenia, and if realistically assessing your activities in this position, you had to practically "mend" others' mistakes.

To some extent, all your predecessors, who held this position after the reign of Armenian National Movement, were engaged in the same activities.

"Fathers" of the domestic democracy, with the help of semi-literate "leaders" of economic thought and semi-criminal elements, quickly dismantled the system of the national economy management, "threw the child along with the water", namely management technology and professional business executives hoping that the "market" automatically will regulate all the socio-economic, production and economic, financial and managerial relationships. The total "invasion" of foreign experts also contributed to it, who, by their understanding and with our agreement, reshaped the domestic system of the country governance.

<u>Remark:</u> I wonder what this "methodological and methodical assistance" cost the country, in the result of which at present we don't have a real economy (not counting the sphere of monopolized business and usurious bank system).

In fact we don't have industry: agro-industry with agriculture are in "agony"; the construction industry is in regression; health and medical care aren't available for wider layers of the population; primary and secondary education is in poor condition; there is no science and higher education; villages are being abandoned, criminal situation is threatening; the corruption has no borders, and it has involved actually the whole system of governance; because of increasing migration the population is aging and the treasury is empty.

Sadly, but the process is on the rise, and no hasty measures are able to help, because even the extra allocation of "social assistance-compensation" for the increase in electricity tariffs to the poorest segments of the population won't stop the total impoverishment of formerly not so needy families.

You are well-informed about the fact that with the increase of electricity tariffs the process of "creeping" increase in prices for the whole range of goods and services in the country will begin. Moreover, we can surely state (as shown by the previous past experience) that the corruption risks in the "objective" definition of the list of families needing social targeted assistance will repeatedly increase.

In the country we have a situation in which "no one is responsible for anything".

Remark: People in the RA National Assembly and in the society "revile" PSRC because of increasing electricity tariffs, but let me ask the same National Assembly and the Ministry of Energy, "You, gentlemen, annually approve a report of activities of the mentioned body and the industrial and economic structures performing this service.

Where have our financial, tax, technical and technological and control structures been?

Has the administration of the company "Electric Networks of Armenia" headed by the General Director E. Bibin suddenly brought the company to the "crisis"?

One thing is clear: if the structure of economy management of the country doesn't qualitatively change at the state level and at the level of local self-government bodies; if the respective functions and tasks aren't clearly defined for each hierarchical level of management; if the cabinet of ministers isn't the "platform" for solving narrow departmental interests; if the institute of personal responsibility isn't introduced at all levels of governance and, most importantly, if the system of appointment of leading cadres doesn't change, which operates on the principle of "personal loyalty", then the country will never overcome this situation.

We have a "stalemate" situation in which there is an intensive growth of social tension among the population. If you do not establish a "direct" dialogue with the population, we can get Kiev "Maidan" in Yerevan.

In this regard it would be reasonable:

- You, as the head of government, appeal to the public about the planned measures on a
 public TV for reducing government expenditure, aimed at free maintenance of the
 state structures of different levels.
- In short term organize financial, technical-technological independent audit of the company "Electric Networks of Armenia". It will allow the RA Ombudsman, in the

- scope of the current legislation, enter the RA Constitutional Court with the suggestion on acknowledging the decisions of PSRC as anti-constitutional.
- Organize special sitting of the RA National Assembly aimed at discussing the activities of PSRC and the RA Ministry of Energy for the last three years.
- The RA Government should develop normative materials on increasing responsibility of ministries, departments and functional-regulating structures for implementing the entrusted functions.
- Charge the RA General Prosecutor's Office and Special Investigation Service with the task in short terms to conduct investigation for revealing outrageous cases of violating the rights of journalists and the participants of the peaceful march on the night of June 23, 2015.
